On confirmation of availability of booth from our office, booth charges payment can be paid online to our Bank Account given below and intimation can be sent to us about payment. Or payment also can be made online by credit/debit card at <https://indiaartfest.in/book-a-booth/>

The booths are numbered serially from G01 to G50 in the art galleries pavilion and A1 to A50 in the artists pavilion. The booth number will be allotted to art galleries and artists on first come first served basis – that is next available booth number as per the booth sequence once exhibitors make the payment. The navigation for visitor to visit all booths is simple as booths are placed serially in the ‘exhibition hall’ in very simple way.

The booth charges payment will be accepted online only and provision to courier the cheque with application form is not available now due to COVID-19 pandemic.

- For the Purpose of terms and conditions, the India Art Festival is to be read as virtual India Art Festival here
- The Exhibitors applying for booth at India Art Festival **agree to observe and abide by the Terms & Conditions** of participation at INDIA ART FESTIVAL / Mumbai Art Fair as mentioned below.
- The **organisers reserve the right to modify, change or issue new terms, conditions & rules of participation** at IAF/MAF for efficient and the safe operation of India Art Festival/Mumbai Art Fair
- The organisers **reserve the right to allocate** the booth at India Art Festival / Mumbai Art Fair
- The booth once booked cannot be cancelled for any reasons at any time. **Exhibitors are requested to book the booth only if they will never cancel booking as we do not have cancellation policy.**
- Further, in case Art Festival/fair is cancelled, abandoned or suspended fully or in part due to the reason beyond the control of organisers, such as war, terrorist attacks, weather conditions, fire, natural calamities, national emergency, law & order problem, labour dispute, venue owners dispute/problems, Pandemics, or any other cause beyond organiser's control, **the organisers will either re-schedule the art festival edition or repay only the proportionate part of booth rent paid by the Exhibitors, after deducting all the expenses incurred on the art festival/fair** including office establishment, advertising & marketing etc right from announcement of the art festival/fair till date.
- If virtual IAF web application, the platform for hosting virtual IAF faces any issue on account of power blackout at the exhibitors', visitors' or server provider's end, and/or IAF web-app becomes unstable due internet issues, speed etc or server disruption for the reasons beyond the control of the organiser, the exhibitors cannot claim refund and IAF will host the event for lost period/days to make up for any such disruption, either partial or full. However, organisers assure that the best server available in the world will be hired to host the virtual IAF.
- **The Exhibitors cannot cancel or reduce the size of the booth once booking is done.** Further, we wish to put it on record that exhibitors participated on their own in the art festival after going through complete enquiries, pros & cons and not due to any allurements from the organisers. It is requested to book the booth after considering all aspects as booth once booked will not be cancelled on any reasons whatsoever and booth charges paid till date will be fully forfeited. In such cases, if amount is not fully paid before payment deadline, the organisers can dispose of booth in whatever the way they think fit to recover their losses due to cancellation/non-payment of dues. The payment made by the exhibitors will neither be refunded nor adjusted in any future editions of India Art Festival. The payment made will also be not adjusted even in the current edition towards the booth of any other exhibitors even if in close blood relation.

- **Artworks of only living artists are allowed to be exhibited in the India Art Festival/Mumbai Art Fair.** The paintings/sculptures by 'Deceased (Non-living)' artists (Bombay School, Bengal school, old masters, modern masters and progressive group artists) are strictly prohibited to be displayed in the India Art Festival irrespective of sound provenance / authenticity of any nature. India Art Festival do not intend to display artworks of deceased artists only to position India Art Festival as a contemporary Art Fair for living artists – which include living established, masters and upcoming artists.
- Art Galleries or artists cannot sublet booth without prior approval from the organisers. **Maximum three booth attendants are allowed in the booth** including gallery director, manager or any of the participating artists.
- The Exhibitors, who book the booths after last entry date for IAF Catalogue, will miss their name in the VIP Preview guide as well as IAF catalogue. No argument in such late booking cases will be entertained from any exhibitors.
- The booth will not be kept reserved beyond one week if 25% booking amount is not made within a week from date of booking. Please note, the booth allocated or charges paid for booth are non-transferable/not refundable.
- Please note that if full payment is not made as per schedule, the organisers reserve the right to cancel the booking and will retain the payment already paid and dispose of aforesaid booth as per their discretion. Anyone booking the booths after above dates has to make full payment at the time of booking itself.
- Mumbai Art Fair and India Art Festival booth cost is available in our application kit online and complaints either from galleries or artists regarding overcharging of booth space in the cases of mutually sublet booths won't be entertained by India Art Festival.
- Art Galleries, Art Dealers who regularly stage public exhibitions on their own space/public galleries or on their websites can apply for a booth at India Art Festival. Booth can be booked jointly by two galleries or independent artists for the group or solo shows.
- The organisers will not return any documents, material & CDs submitted to India Art Festival for any purpose.
- The Application will be considered valid only when full booth booking amount is paid or if amount is transferred online to the beneficiary account mentioned under payment information.

- The participation in the official IAF catalogue published by the organisers is obligatory for the Exhibitors. The organisers reserve the right to edit/modify/re-size any catalogue information/text/images supplied by the Exhibitors.
- All verbal communication, consents and approvals shall be considered valid only if confirmed in writing/email by the organisers. The disputes, if any, are subject to be settled only by the law enforcement agencies under the jurisdiction of Mumbai, India.
